## AN ORDINANCE AMENDING THE OFFICIAL ZONING ORDINANCE OF CITY OF CLINTON, MISSISSIPPI AS IT RELATES TO CELLULAR SITES

**WHEREAS**, a public hearing, pursuant to Section 3006.05 of the Zoning Ordinance of City of Clinton, Mississippi, was set for the 26<sup>th</sup> day of January 202 l, at 6:30 o'clock P.M.; and,

WHEREAS, City of Clinton did cause notice of said hearing to be published in the Clarion-Ledger. a newspaper published in Hinds County, Mississippi, in the manner and for the time required by law; and,

WHEREAS, at the time, date and place specified in the Notice, the City of Clinton Planning Commission did conduct a full and complete hearing, and thereafter, did forward their recommendation for approval to the City of Clinton Mayor and Board of Aldermen; and

**BE IT ORDAINED** by the Mayor and Board of Aldermen of City of Clinton, Mississippi that the Official Zoning Ordinance of City of Clinton be amended as follows:

## AMENDMENT TO ZONING ORDINANCE

The City of Clinton Zoning Ordinance is hereby amended as follows:

Section 406.10 Remove: Driveways cannot cover more than 50% of the front yard and a driveway must be solid surfaced with brick, asphalt or concrete.

Add: Section 406.16: <u>Driveways for Single-Family Residential Dwellings:</u>

Driveways cannot cover more than 50% of the front yard and a driveway must be solid surfaced with brick. asphalt or concrete., EXCEPTION: Driveways on lots one acre or greater and more than 300' from right of way (ROW)

This Ordinance shall be effective on the 4<sup>th</sup> day of March, 2021.
