#### DEPARTMENT HEAD REPORT

Before Chandra Broomfield, Director of Therapeutic Recreation gave her report the Mayor read two notes from citizens of Clinton thanking the City and Chandra for reopening the Therapeutic Recreation Center and providing the activities that were put on hold during the COVID-19 pandemic. Chandra then updated the board on the ongoing activities held over the past several months. These activities included Top Soccer, an Art Exhibit, Penny Auction, and a Beginner's Line Dancing Class. She also updated the board on the total number of participants and on the COVID-19 precautions being taken during the activities. Chandra then updated the board on the various activities planned for the Center for the months of October 2021 through December 2021.

#### **PUBLIC HEARING**

A Public Hearing was held to discuss the 2021-2022 proposed budget and the 2021-2022 tax levy for the City of Clinton, Mississippi. The Mayor opened the Public Hearing by discussing the major items in the budget. These items included salary increase for the employees, additional police personnel and vehicles, beautification, new equipment for both Parks and Recreation and Public Works and the budget also included the borrowing of \$925,000 from the Water and Sewer Department for the Quail Hollow and Pebble Brook projects with a ten-year payback. He also spoke of the equipment and projects in the budget pertaining to the Water and Sewer Department. (His comments are made a part of these minutes).

The Mayor then asked for any comments from the Board of Aldermen. Alderman Barnett made the comment that he did not feel the City needed to borrow the \$925,000 from the Water and Sewer Department for the Quail Hollow and Pebble Brook projects. He felt the City should wait and see if they could get the money from the Federal Government.
