Probationary Firefighter I Job Description

Nature of Work

This is a skilled position for training in Emergency Medical Service (EMS) and fire fighting operations.

Duties include training and participation in the operation of fire fighting apparatus, EMS operations and the performance of hazardous duties under emergency conditions. Work entails combating, extinguishing, and preventing fires, EMS operations and in the operation of routine custodial maintenance of department equipment, apparatus, and quarters.

An employee of this class is responsible for the protection of life and property through fire fighting, rescue, EMS and related duties. Work may require strenuous exertion under such handicaps as smoke, fire, heat, and cramped surroundings. When required, to participate in drill and study programs and to perform routine duties in the care and maintenance of station equipment, apparatus, buildings, and grounds. Work is normally performed under close supervision in accordance with established policies and procedures. Assignments are given by a superior officer both in emergency incidents and at the station. Work is usually reviewed for adherence to standards and through reports and accomplishment of desired results.

Ventilates burning buildings by opening windows and skylights or by chopping holes in roofs and floors.

Removes persons from danger; administers first aid to injured persons; performs salvage operations such as sweeping water and moving debris.

Inspects building and premises for familiarization; checks for fire hazards.

May drive and operate motor driven equipment under special instructions and limited conditions on a Relief basis

Firefighter II III Job Description

Nature of Work

This is a skilled position for EMS and fire fighting operations.

Duties include participation in the operation of fire fighting apparatus, EMS operations and the performance of hazardous duties under emergency conditions. Work entails combating, extinguishing, and preventing fires, EMS operations and in the operation of routine custodial maintenance of department equipment, apparatus, and quarters.

An employee of this class is responsible for the protection of life and property through fire fighting, rescue, EMS and related duties. Duties include training and participation in the operation of fire fighting apparatus and the performance of hazardous duties under emergency conditions. Work may require strenuous exertion under such handicaps as smoke, fire, heat, and cramped surroundings. When required to participate in drill and study programs and to perform routine duties in the care and maintenance of station equipment, apparatus, building, and grounds. Work is normally performed under close supervision in accordance with established policies and procedures. Assignments are given by a superior officer both in fire fighting and at the station. Work is usually reviewed for adherence to standards and through reports and accomplishment of desired results.

Responds to fire alarms with a company; lays connects hose; holds nozzles and directs water streams; climbs ladders; uses chemical fire extinguisher, bars, hooks, lines and other equipment.

Ventilates burning buildings by opening windows and skylights or by chopping holes in roofs and floors.

Removes persons form danger; administers first aid to injured persons; performs salvage operations such as sweeping water, and moving debris.

Participates in fire drills; and studies assigned materials relating to fire fighting, fire prevention and EMS.

Inspects building and premises for familiarization; checks for fire hazards.

May be requested to drive and operate motor driven equipment, when properly trained, on a Relief basis.

Performs other duties as assigned.

Desirable Knowledge, Abilities and Skills

Working knowledge of occupational hazards involved in the work and the safety precautions for safe performance of the job.

Ability to learn a wide variety of fire fighting duties and methods within a reasonable time period.

Ability to act quickly and calmly in emergency situations.

Ability to climb ladders and work at considerable heights.

Ability to establish and maintain effective working relations as necessitated by work assignments.

Ability to understand and follow oral and written instructions.

Ability to meet prescribed medical and physical standards, and physical strength to do prolonged and arduous work under adverse conditions.

Ability to accept responsibility in position of higher rank.

Must maintain a valid Mississippi Vehicle operator's license.

Firefighter II III

Firefighter II (Relief Driver Operator and FF- I completion)

- -Driver Operator (80 Hours)or NFPA 1002
- -Relief Driver Operator I (Pumpers 1, 2, 3 and Reserves) Minimum 1 Year at CFD
 - -Relief Driver Operator II (Truck 1) Minimum 6 months RDO I
 - -Relief Driver Operator I and II Certification for a minimum of 12 months

Firefighter III

- -Hazardous Materials Technician Level I (80 Hours)
- -Note: Only 40 Hours will be credited to Specialty Course I Requirements
- -Minimum 8 Hours of inservice a year for Lieutenant
