## **Discussion/Action**

**Exemption from Ad Valorem Tax** for Gulf State Canners, McNeely Plastics and McNeely Real Estate holdings which eliminates property taxes for an extended period of time for manufacturing businesses and industries, in this case, those who have been established as Free Port Warehouses because they store and resale goods outside the state of Mississippi.

**Election approvals** for the Municipal Elections held on April 1, April 22 (if necessary), and June 3, 2025. These approvals include the execution of agreements for the election machines and support services in addition to the approval of polling locations.

**Approval to appoint** Rodney Harris and Russell Wall as members of the City of Clinton Election Commission. This group is not affiliated with any party and assume election-related responsibilities during a general election.

**Addendum approval to** clarify and reaffirm the agreement with the Clinton, Raymond, Bolton Wastewater Authority (CRBWA) as a joint agreement between all parties to see the project through to completion.
